- 1.) To provide volunteer workers for the major work days scheduled.
- 2.) To provide volunteers to help collect & handle birds and crates on the release date(s). Clubs are strongly urged to supply their own carrying crates. When necessary, each club will need to make arrangements to pick up OCFS crates and return to the Jamesville Correction Facility the same day of the release in order other clubs may reuse.

Participants should arrive 45 minutes ahead of schedule & plan on remaining 45 minutes after scheduled time to help collect & handle pheasants.

- 4.) **JAMESVILLE CORECTIONAL FACILITY POLICY** mandates the following:
 - ** No women or children under 18yrs of age EXCEPT when prisoners not on site (wkends).
 - **No Cameras **No firearms, knives or animals.
 - **Everyone entering must notify ahead & have valid I.D. to enter at expected times.
 - **Vehicles to be parked without blocking the road & kept locked at all times.

5.) **RELEASING REGULATIONS:** The Onondaga County Federation of Sportsmen's Clubs operates the "Pheasant Release Program" for the benefit of the member clubs and under the direction, rules & policies of the New York State D.E.C. Division of Fish & Wildlife. Requirements dictate that pheasants are reared for recreational hunting purposes and birds be released on land open to the public hunting.

A signed statement is required for pick up by the responsible person ordering these birds stating where, when, and by whom the birds will be released and asserting that birds will be released as per D.E.C. rules & policies.
